How you can help:

At least 8,500 plastic filled eggs are needed for the 700+ children who will participate in the Easter Egg hunts. Our goal is to make sure each child goes home with at least 10 to 12 eggs. Any amount of eggs you can donate will be greatly appreciated. You can drop off the plastic filled eggs to the BR Bar Association office between 9:00 a.m. and 4:30 p.m. Monday-Friday, **beginning Friday, March 5, 2010. The final date to drop off eggs is Friday, March 19, 2010.**



*Donate filled Easter Baskets.

We will need at least **118** Easter Baskets filled with candy and other goodies for children ages 3-10 to donate to Family Services of B.R. Please drop off your filled basket(s) at the BR Bar office no later than **Friday, March 19, 2010.**

*Volunteer to participate in an Easter Egg Hunt.

We will have hunts at four (4) elementary schools during the **week of March 22, 2010.** The hunts at each school will take approximately 1-1 ½ hours of your time, and the excitement of the children is so rewarding. Please look at your calendar and see if you can join us for one or more of the hunts. The dates and times are listed below. **Please arrive 30 minutes before the hunt to hide the eggs.** The hunt itself lasts only about two to five minutes.
